Re: Survey of Executive Airport Tenants

The City of Avon Park is considering the submittal of an application to the Federal Aviation Administration under the Airport Investment Partnership Program (AIPP) to provide a long-term 30-year, (with two optional renewal periods for a total of 49 years) lease of the City of Avon Park Executive Airport to Florida Airport Management, LLC (FAM) via a subsidiary, Florida Airport Management KAVO, LLC. FAM has provided professional management of the Executive Airport since April 2022, through an Operations Agreement with the City. Under the proposed lease agreement, the Executive Airport will remain a public use airport available to tenants and users.

The goals of the City of Avon Park under the AIPP application include the following:

- Provide professional management of the Executive Airport to ensure the Airport meets FAA and FDOT operational, safety, security, and state of good repair standards.
- Grow the Airport operations to help the Executive Airport become self-sufficient from Airport revenues. (Since the Executive Airport was developed the City has subsidized the operations of the Airport with other City funds.)
- Enhance the economic development of the City of Avon Park by providing the opportunity for growth of aeronautical and non-aeronautical facilities at the Airport to enhance services, increase Airport revenues, provide jobs and increase the overall economic activity for the City and County.
